Prescription for Lake Aquatic (vegetation) Navigation

Big Bear Municipal Water District's Prescription for Lake Aquatic vegetation Navigation (P.L.A.N.) is designed to effectively control the Lake's native vegetation while simultaneously attempting to eradicate invasive plants and keep navigation for vessels open and accessible.

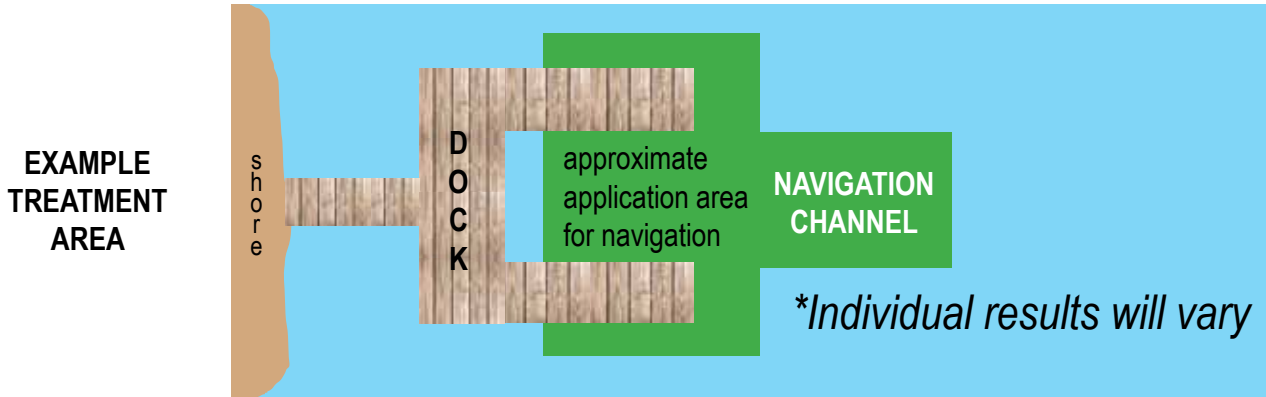
The P.L.A.N. program runs seasonally June 15 through September 15. After the initial entire Lake application, the District will continue to survey the Lake and implement P.L.A.N. treatments based on the largest areas of vegetation forming that inhibit ingress and egress from docks.

MECHANICAL HARVESTING

- The mechanical harvester can only be used for navigational purposes on native vegetation.
- The mechanical harvester will not be used on Eurasian water milfoil.
- The District retains ultimate discretion on which treatment method will be utilized in your area.

CHEMICAL HARVESTING

Lake conditions vary. The District will make every effort to apply only when conditions are optimal for surface applications.

Chemical Harvesting

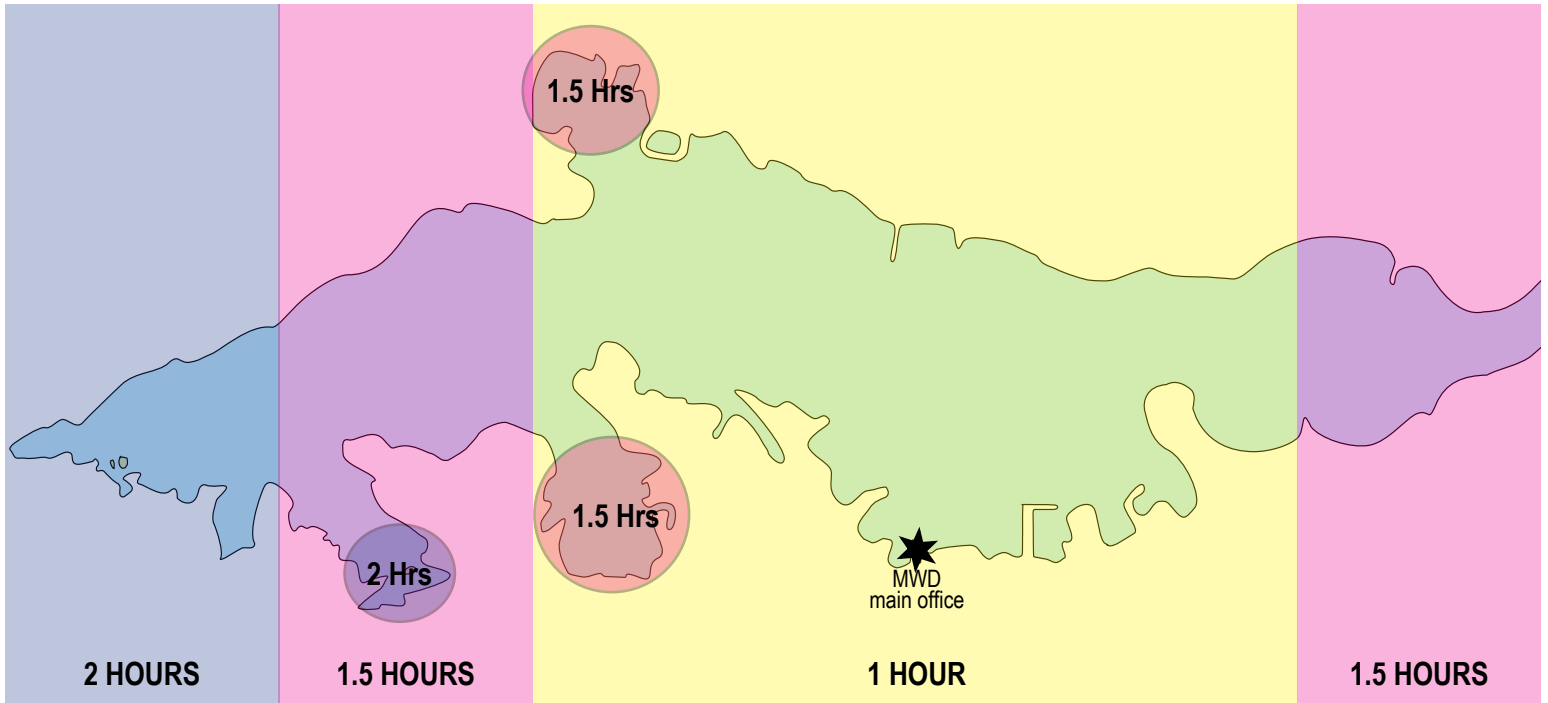
\$175.00 per hour + actual cost of herbicide

Please note that contact herbicide treatments and mechanical harvesting do not prevent floating fragments from drifting in to your area nor does the District currently have a fee schedule for that type of work.

Approximate travel time for harvester - round trip, portal to portal.



*Travel times are an estimate only based on the harvester leaving the District office and travelling to the dock location and either applying herbicide -or- harvesting native vegetation then returning to the main office. The District will make every effort to combine nearby dock applications into a single trip to maximize efficiency and share some of the travel time. Use these estimates as a starting point for gauging how much you will be required to pay for additional P.L.A.N. services. Individual invoices may vary.
