Non-Registered Vessels

Non-motorized boats and sailboats 8 feet or less in length, kayaks, canoes, sailboards, paddleboards, fishing float tubes

NON-REGISTERED PERMITS ARE NO LONGER AVAILABLE FOR PURCHASE THROUGH THE MAIL

A quagga inspection must be performed at the time of purchase for all non-registered vessels. This purchase and inspection can be done at any BBMWD launch ramp or marina that sells non-registered permits.

*Quagga Prevention Program Surcharge is waived for California registered vessels when grant reimbursement is received.

By submitting payment, you agree to the following conditions for issuance of a Lake Use Permit:

1. This permit to operate a boat on Big Bear Lake (herein "Lake") is subject to regulations governing the operation of boats on Lake, now, or hereafter be established by the Big Bear Municipal Water District (herein "District").
2. This 2019 seasonal Lake Use Permit expires 3/31/20. This permit can be terminated for failure to comply with the terms of this permit or regulations, without refund of the permit fee. Owner/operator shall remove the boat from the Lake upon receipt of notice of revocation of permit. If the boat is not removed, the District may cause the boat to be removed and stored at the expense of the owner.
3. Owner shall save, defend, hold harmless, and indemnify District, its officers, agents and employees free and harmless from claims, costs, attorney's fees, for damage and harm arising out of owner's use of a boat pursuant to this permit.
4. The boat shall be launched at a site approved by the District and in compliance with regulations concerning invasive species.
5. By purchasing a Lake Use Permit I certify that my vessel will be clean, drained, and dry prior to entering the water in order to prevent quagga or zebra mussel infestation in Big Bear Lake. I also certify that after using my vessel in any other fresh water body it will be clean, drained, and dry prior to launching on Big Bear Lake.
